Ogden New Eastside Pay Bus 2017-18 Terms and Conditions

- 1. Bus Service Mission Statement.** The mission of the Ogden New Eastside Bus is to provide basic commuting transportation between the New Eastside neighborhood stops and the two campuses of Ogden International. There is no intention of or agreement to take roll before scheduled departures from any stop. It is the responsibility of each student to arrive at designated bus stops and to board/disembark the bus in a timely manner. If a student misses a bus departure, the parent or guardian assumes responsibility for transporting the student to or from school. Parents or guardians are also responsible for meeting students when they return from school if their child should need an escort.
- 2. Student Responsibilities.** Student will board and exit at a stop designated on the registration application. Student agrees to remain properly seated in a seat when the bus is moving, agrees to speak respectfully on the bus, agrees not to yell, sing loudly, or use profanity on the bus, and agrees not to touch another student or property of another student without express permission of that student. Student agrees to report immediately to the driver any concern, problem, or inappropriate behavior personally observed on the bus that may impact or hurt himself or herself or another student. Student agrees not to consume food or drink, other than water, on the bus. Student agrees to properly dispose of all waste into waste receptacles and not leave any litter on the bus. Student will not engage in any action that might damage the vehicle.
- 3. Fees.** We agree to pay a deposit of \$500.00 by cashier's check or money order payable to: "AI Bus Services LLC". The remaining balance, as determined by the total number of families that sign up, will be paid on a date which will be communicated by the parents organizing this service. We also agree to pay \$10 cash for a personalized student bus identification card. Replacement cards are additional \$10. Deposits and ID card money will be paid before June 9th, 2017. We understand that NO REFUNDS will be made for any deposits or other amounts collected.
- 4. Bus Identification Card.** A personalized bus identification card is issued to every student and is required to ride the bus. The card must be attached to the student's book bag AND be visible to the driver. Student will be let on or off the bus at the location specified on the card, unless there is prior notification to the driver. Replacement ID cards are \$10. Student will report any lost ID card immediately to ogdenpaybus@gmail.com.
- 5. Delays.** We understand, appreciate, and accept that travel time to and from Ogden School may fluctuate based on traffic, construction, weather, and unforeseen circumstances. Bus schedule times may be modified occasionally following notice to families to improve timeliness of the service. We understand that in emergency situations communications of delays will be attempted; otherwise, delays due to traffic, weather, or construction will not be communicated.
- 6. Bus Driver Authority.** The bus driver is in charge of the bus. Student agrees to follow all rules, directions and instructions of the driver. The driver will immediately investigate all issues brought to his/her attention. The driver is in charge of resolving issues that occur on the bus. If necessary, the bus driver may contact a student's parent or guardian to resolve an issue. If a problem continues repeatedly, becomes more serious, or cannot be resolved by the driver, the issue may be brought to the Ogden School. We, as parents and students, understand the CPS Student Code of Conduct applies to this School Bus. If necessary, the school may choose to prepare an incident report or misconduct report. Chronic violations of bus rules may result in removal of the student from the bus without refund.
- 7. Schedule.** We agree to follow the schedule established by the transportation provider. We understand that if the student misses the bus, the parent/guardian assumes the responsibility of providing transportation for that student to school OR from school.
